The private limited liability company, incorporated in accordance with Belgian law, "WISEMEN", with registered office at 3590 Diepenbeek, Watertorenstraat 2, with company registration number 0503.920.245 and known to the VAT-administration under number BE 0503.920.245 (hereinafter referred to as "Wisemen", "we" or "us");

Wisemen uses cookies to improve the browsing experience at https://wisemen.digital (hereinafter referred to as the "Website"). These cookies enable certain functions on our Website or measure how visitors use our Website.

With this cookie policy ("Cookie Policy") we wish to inform you, as a visitor to our Website, about the cookies and other tracking methods we use (and the way we do this).

What are cookies?

A cookie is a small text file that is placed in your computer's browser or on your mobile device by a website's server when you consult this site. The cookie contains a unique code that allows your browser to be recognized during visits to the website (this is a so-called 'session' cookie) or during subsequent, repeated visits (a so-called 'permanent' cookie). Cookies can be placed by the server of the website you visit or by partners with whom the website cooperates (e.g. Google Analytics, ...). A website's server can only read the cookies it has placed itself and has no access to other information stored on your computer or mobile device. Cookies are stored on your computer or mobile device in a specific folder of your browser.

Cookies generally make interaction between the visitor and the website easier and faster and help the visitor to navigate between the different parts of the website. Cookies can also be used to make the content of the website more relevant to the visitor and adapt it to his personal taste and needs.

This Website uses different types of cookies and tracking methods

I. Stricly necessary cookies:

These cookies are necessary for purely technical reasons for the use of the Website. In view of the technical necessity, there is only an information obligation and they are placed as soon as one enters the Website.

II. Functional cookies

These cookies improve the functionality of the Website by storing your preferences. We use functional cookies, among other things, to:

These cookies are necessary for the proper functioning of this Website. You cannot refuse them if you want to browse the Website, but they will only be placed after a choice has been made regarding the use of cookies.

III. Analytical cookies

IV. Advertisement cookies

- Cookie content;
- Device settings.
